- As the Health and Safety Advisor you will work towards achieving HSE vision and goals. You will provide Health and Safety support to all specified projects as requested, through various aspects of pre-project, design, engineering, procurement, construction, commissioning, contractor management and start up through to operations.

ACTIVITIES INCLUDE:

Provide coaching and mentoring to the various line/project managers to set appropriate objectives for HSE contractor management and Emergency Response Plan management and implementation.

- Lead a HSE Contractor Management Working Group
- Ensure the selection and use of competent contractors by the affiliate through program evaluation and management system audits
- Collaborate with Contracts and Procurement to develop appropriate standards for contractor selection, evaluation and measurement
- Support Hazard Identification and Risk Assessments for contracted activities
- Work with project management teams to develop annual improvement plans for contractor management
- Support development of HSE Management Plans for key contractors with line/project managers
- Organize contractor audit programs including coordination and recordkeeping of site audits with HSE Advisors
- Support pre-evaluation and pre- project inspections, onsite contractor field audits and post project appraisals
- Work with selected strategic contractors (typically local and/or aboriginal) to improve HSE programs
- Implement and continually develop Emergency Response Plan
- Communicate all changes to the Emergency Response Plan to effected parties such as the Duty Managers and Duty Officers
- Organize training for the roles of Duty Manger and Duty Officer within the Emergency Response Plan
- Develop and organize Emergency Scenario drills at the affiliate level as well as supporting the drills at the field level
- Analyse and trend HSE statistics for future HSE planning and project implementation
- Participate and Lead HSE management system audits of internal process and Contractor HSE systems
- Participate in Incident Investigations and develop and implement actions to mitigate reoccurrence
- Completion of other activities as directed

Requirements:

HSE certificate, CRSP is an asset, H2S, Confined Space entry, 2nd level first aid, 2 to 4 years oil drilling field experience.
Previous Gulf experience great advantage.
